Transportation News...

Success Stories: *This feature shows how individuals' lives are positively changed by using services at New Horizons. Please note that names have been changed to protect their privacy.*

This Success Story Comes From New Horizons' Transportation:

A senior couple who lived in the Cordes area desperately needed transportation to get to urgent medical treatments since they lived quite a long way from the medical services in both Prescott and Prescott Valley. As they were seniors living on a low income and the wife did not drive, it was critical that the husband get to medical care. After being given numerous rides to necessary doctors' appointments provided through a senior funding resource, they indicated that he would have died without transportation to get to his appointments. After being given information about benefits, they now receive benefits assistance for disability and from Arizona Long Term Care. They informed New Horizons that they were in dire straits and were so grateful for New Horizons' transportation that got him to many necessary medical treatments and saved his life.

Transportation services are provided to anyone, any age, not just for individuals with disabilities. Vehicles include accessible, lift-equipped vans, trained drivers, and passenger cars. Call about rides out of the area. Vouchers accepted.

New Lions Program Provides Free Rides to the Blind

The Lions Volunteer Transportation for the Blind group will use their own vehicles to provide rides at no cost for blind residents to life-enriching or educational or entertainment events which are not readily available due to lack of mobility. An answering service will take calls from pre-qualified riders and schedule rides within 24 hours of the call. Updates from the Social Security Administration

Below is this quarter's update from the Social Security Administration (SSA). Don't forget to visit the SSA website at www.socialsecurity.gov for information and answers on all social security topics.

Social Security

I lost my Social Security card, but I remember my number. Do I really need a new card?

No, probably not—but it *is* important to know your number. The only time you may need the Social Security card is if your employer asks for it when you get a new job. If you do decide to get a new card or your lost one turns up, don't carry it with you. Keep it with your other important documents. Generally, you are limited to three replacement cards a year and 10 cards during your lifetime. Legal name changes and other exceptions do not count toward these limits. Keep in mind this is a free service. Learn more at www.socialsecurity.gov/ssnumber.

I noticed that my date of birth in Social Security's records is wrong. How do I get that corrected?

To change the date of birth shown on our records, take the following steps:

Complete an *Application For A Social Security Card* (Form SS-5);

Show us documents proving:

- U.S. citizenship (if you have not previously established your citizenship with us);
- Age; and
- Identity; and

Take (or mail) your completed application and documents to your local Social Security office.

Medicare

I am 65 and my wife is 62 and receiving spouse's benefits. When will she qualify for Medicare benefits?

Most people must wait until age 65 to qualify for Medicare benefits. Some people can get Medicare at any age, including those who:

- Have been getting Social Security disability benefits for 24 months or more;
- Have kidney failure and require dialysis;
- Have had a kidney transplant; or
- Receive disability benefits because they suffer from amyotrophic lateral sclerosis (also known as Lou Gehrig's disease).

You can apply online for Medicare at www.socialsecurity.gov/medicareonly.

Bringing Mental Health First Aid to Our Community

Western Arizona Council of Government's Area Agency on Aging in partnership with Cenpatico of Arizona provided an Adult Mental Health First Aid Training for the Yuma community on May 20th, 2014. A total of 25 individuals successfully completed the training.

The training is a public education program that introduces participants to risk factors and warning signs of mental illnesses, builds understanding of their impact, and overviews common supports. This 8-hour course uses role-playing and simulations to demonstrate how to offer initial help in a mental health crisis and connect persons to the appropriate professional, peer, social, and self-help care. Like CPR, Mental Health First Aid prepares participants to interact with a person in crisis and connect the person with help.

First Aiders do not take on the role of professionals — they do not diagnose or provide any counseling or therapy. Instead, the program offers concrete tools and answers key questions, like “what do I do?” and “where can someone find help?”
